I declare that I meet the following eligibility requirements to serve on the Inyo County Grand Jury:

- I am over the age of eighteen (18) years.
- I am a citizen of the United States of America.
- I have been a resident of the County of Inyo, State of California, for the past twelve months, and continue to be a resident of Inyo County.
- I am in possession of natural faculties, ordinary intelligence, of sound judgment and of fair character.
- I am possessed of sufficient knowledge of the English language to serve as a grand juror.
- I have not been discharged as a grand juror within the past twelve (12) months.
- I am not currently serving as a trial juror in any court of the state of California.
- I have not been convicted of malfeasance in office, or of any felony or other high crime.
- I am not now serving as an elected public officer.
- You may publish my name as a potential Grand Juror.

I understand that my name has been placed in nomination to be considered for membership on the Grand Jury of Inyo County for the fiscal year **2021-2022**.

I am aware that such service has, over the past several years, required at least one day per week.

I am further aware that service is for twelve months, and that vacations are at the option and convenience of the jury and may be limited to one month or less.

Now, therefore, I have read and understand the above and hereby state, that I am in good health, that I have no plans for vacation, travel, or business which would prevent me from serving the required amount of time.

I recognize that my attendance will be expected, and may be required by the Foreman of the Grand Jury.

I therefore request that my name be placed on the eligible list as a candidate for the Grand Jury.
